At the workshop Staff anticipates discussing proposed revisions to try and address some of these initial concerns. After the workshop Staff may further revise the rulemaking based on workshop feedback. Staff intends to present a list of unresolved concerns to the Commission along with Staff's written response to those unresolved concerns.
