ORDER RECOGNIZING REORGANIZATION AND NAME CHANGE AND APPROVING TARIFF SHEET

GST Net, Inc. (GST) submitted to the Commission on October 23, 1997, a tariff sheet and Missouri Secretary of State's certificates reflecting a corporate reorganization. GST is the parent corporation to International Telemanagement Group, Inc. (ITG) which was granted an interexchange certificate of service authority to provide services in Missouri in Case No. TA-94-324 on July 24, 1994. ITG is classified as a competitive company and, accordingly, the Commission does not require compliance with Section 392.340, RSMo 1994, which subjects reorganizations to Commission supervision and control.

reorganization, ITG would be providing services under the corporate name, "GST Net, Inc." The reorganization resulted in no change in ultimate ownership, management or control of ITG. The company will continue to operate under ITG's approved tariff. The tariff sheet submitted on October 23 consists of an adoption notice wherein GST adopts the tariff approved for ITG.

The Staff of the Commission (Staff) filed a memorandum on October 28, 1997, stating that Staff had no objection to the Company's filing and recommending that the Commission issue an order recognizing the corporate reorganization and approving the adoption notice. Staff states that it is unaware of any other filing which affects or which would be affected by this proposal.

The Commission has reviewed GST's filing and adoption notice, and Staff's recommendation, and finds that ITG's change of corporate name should be recognized and the adoption notice should be approved to because effective on November 1, 1997.

IT IS THEREFORE ORDERED:

- 1. That the change of name from "International Telemanagement Group, Inc." to "GST Net, Inc." is recognized.
- 2. That the certificate of service authority previously issued to International Telemanagement Group, Inc. in Case No. TA-94-324 on July 22, 1994, is amended to reflect the change in corporate name from "International Telemanagement Group, Inc." to "GST Net, Inc."
- 3. That the tariff sheet filed by GST Net, Inc. on October 23, 1997, is approved. The tariff sheet approved is:

4. That this order shall become effective on November 1, 1997.

5. That this case shall be closed on November 2, 1997.
