ORDER SUSPENDING TARIFF, GRANTING INTERVENTION AND ESTABLISHING PREHEARING CONFERENCE

On December 7, 1994, Kansas City Power & Light Company (KCPL) filed a motion for a protective order to protect information it considers confidential associated with a special contract between KCPL and one of its customers. The Commission established this docket to consider the motion and on December 9, 1994, the Commission issued an order establishing a protective order as requested.

On December 16, 1994, Trigen-Kansas City Energy Corporation (Trigen) filed an application to intervene in this proceeding. Trigen contends that its interests are different from those of the general public since it competes directly with KCPL. On December 23, 1994, Missouri Gas Energy, a division of Southern Union Company, (MGE) filed an application to intervene and a motion to suspend the KCPL tariff.

The Commission has reviewed the applications to intervene and finds that Trigen and MGE have interests different from those of the general public and will grant them intervention in this case. The Commission has also considered MGE's request to suspend the tariff and finds that the request should be granted.

The Commission is suspending the special contract tariff and will set a prehearing conference for the parties to address the substantive and procedural issues involved in this case. The Commission also finds that the parties should

address the issues of the confidential treatment of these special contracts and whether that confidentiality is in the public interest and is permitted by relevant statutes and Commission rules. In addition, the Commission is concerned with the rates to be charged pursuant to this special contract. The rates and any ratemaking treatment concerning these contracts should also be addressed.

IT IS THEREFORE ORDERED:

- 1. That Trigen-Kansas City Energy Corporation is hereby granted intervention in this case.
- 2. That Missouri Gas Energy, a division of Southern Union Company, is hereby granted intervention in this case.
- 3. That a prehearing conference is now set for January 18, 1995, at 10:00 a.m. in Conference Room 3, Room 530, Harry S Truman State Office Building, 301 West High Street, Jefferson City, Missouri.
- 4. That the tariff submitted by Kansas City Power & Light Company for a special contract on December 7, 1994, is hereby suspended one hundred twenty (120) days beyond the effective date of January 6, 1995, to May 6, 1995.
- 5. That this order shall become effective on the 6th day of January, 1995.
