### ORDER DIRECTING FILING

On November 23, 2021, the Raytown Water Company (Raytown) filed an application for an order authorizing issuance of water facilities refunding and improvement bonds, series 2008. Raytown states that the proceeds from the proposed bond issuance are to be used: (a) to update the entire water metering system to AMI by replacing all manually read meters with radio readers; (b) to upgrade meter wells as needed; (c) to install new data collectors; (d) to update metering software and make live metering information available to customers through the company website; (e) to purchase new trucks; (f) to replace the roof on the main office and install a back-up generator; (g) to construct a new garage to house company-owned vehicles; and (h) to pay the costs and expenses of the issuance of the bonds, including the costs and legal expenses of the application and proceeding for authorization to issue the bonds. The Commission will be aided by a recommendation from its Staff. Therefore, the Commission will direct its Staff to file a recommendation or a status report indicating when it will be able to file a recommendation.

### THE COMMISSION ORDERS THAT:

- 1. No later than December 24, 2021, the Commission Staff shall file its recommendation or a pleading stating when it will file its recommendation.
  - 2. This order shall be effective when issued.
