**ORDER DIRECTING STAFF RECOMMENDATION
AND SETTING A DEADLINE FOR RESPONSES**

On November 23, 2021, The Raytown Water Company (Raytown) filed an application with the Commission requesting authority to issue Water Facilities Refunding and Improvement Bonds through the Environmental Improvement and Energy Resources Authority (EIERA) not to exceed \$5 million at an interest rate not to exceed 3.25% per year.

On January 28, 2022, the Staff of the Commission (Staff) filed its recommendation that the Commission approve Raytown’s application with certain conditions. No responses to Staff’s recommendations were filed.

On February 15, 2022, Raytown filed an *Amendment to Application* in which it replaced numbered paragraph 7 of its application, describing the securities it seeks approval to issue. To aid the Commission’s evaluation of Raytown’s application, the Commission will order Staff to provide an updated recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file an updated recommendation on Raytown’s application, taking into account the amendment filed on February 15, 2022. Staff’s recommendation shall be filed no later than February 17, 2022.

2. Responses to Staff's recommendation shall be filed no later than 1:00 p.m.,
February 22, 2022.

3. This order is effective when issued.
