Issue Date: December 20, 2021 Effective Date: December 20, 2021 On December 15, 2021, Missouri-American Water Company (MAWC) filed an application for authority to engage in a variety of unsecured debt financings during a three-year period following the effective date of an order approving MAWC's financing plan. The Commission will be aided by a recommendation from its Staff. Therefore, the Commission will direct its Staff to file a recommendation or a status report indicating when it will be able to file a recommendation.
