ORDER DIRECTING STAFF TO FILE A RECOMMENDATION

On August 1, 2022, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed applications seeking authority to issue long-term debt to CoBank, ACB in an amount not to exceed \$7.2 million. Along with its application, Confluence also filed a motion for waiver of the notice requirements of Commission Rule 20 CSR 4240-4.017(1). The Staff of the Commission (Staff) will be directed to file a recommendation or a status report indicating when it will be able to file a recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file either its recommendation or a status report indicating the date on which it intends to file its recommendation no later than September 19, 2022.
2. This order is effective when issued.
