NOTICE OF INTENDED CASE FILING

COMES NOW Windstream NuVox of Missouri, Inc., (“Windstream NuVox”), by and through counsel, and files this Notice of Intended Case Filing. In this regard, Windstream NuVox respectively states to the Missouri Public Service Commission (“the Commission”):

1. Windstream NuVox is a competitive telecommunications company authorized to provide local exchange and interexchange telecommunications services in Missouri. It is also authorized by the FCC to provide interstate and international telecommunications services. Its principal Missouri offices are currently located at 12400 Olive Blvd, Suite 430, St. Louis, MO 63141 (Contact Ed Cadieux: tel 636-537-5743, fax 636-733-5743, email Edward.Cadieux@windstream.com).

2. Commission Rule 4-CSR 240.4.020 provides, in pertinent part, as follows:

(2) Any regulated entity that intends to file a case likely to be a contested case shall file a notice with the secretary of the commission a minimum of sixty (60) days prior to filing such case. Such notice shall detail the type of case and issues likely to be before the commission.

3. It is Windstream NuVox’s intent to file a complaint against Southwestern Bell Communications Company d/b/a AT&T Missouri (“AT&T”) alleging that AT&T is violating the interconnection agreement (“ICA”) approved by the Commission between Windstream NuVox and AT&T. The issues that are likely to be presented include whether AT&T is in violation of the ICA due to AT&T’s failure to provide Windstream NuVox the option of choosing whether test equipment is deployed by AT&T on less than both of the two cross-connects provided on

each Enhanced Extended Loop (“EEL”) ordered by Windstream NuVox, and whether AT&T has overcharged Windstream NuVox for such cross-connects.

WHEREFORE, Windstream NuVox submits to the Commission and its Secretary this Notice of Intended Case Filing.
