### ORDER SUSPENDING PROCEDURAL SCHEDULE

Metro Connection, Inc. d/b/a TransAmerican Telephone ("Metro Connection") filed an application on June 23, 1997, requesting a certificate of service authority to provide basic local telecommunications service and requesting competitive classification. The Commission issued its Order Adopting Procedural Schedule on September 26. Metro Connection filed an amended application and a motion to suspend the Commission's procedural schedule on October 16. Metro Connection stated in support of its motion that its application has been amended to remove requests for certain waivers, that it anticipates that the parties will ultimately enter into a Stipulation and Agreement as a result of such removal, and that none of the parties is opposed to its motion to suspend the procedural schedule. Metro Connection did not request any specific period of time for suspension. No party filed a response to Metro Connection's motion.

The Commission finds that it is in the public interest to suspend its previously adopted procedural schedule for a period of approximately 60 days in order to give the parties an opportunity to negotiate a settlement. The Commission finds that the conditions established in its order of September 26 shall continue to apply.

#### **IT IS THEREFORE ORDERED:**

1. That the procedural schedule adopted by the Commission on September 26 is temporarily suspended, and the procedural deadlines are extended to the following dates:

2. That the procedural schedule shall remain subject to the conditions discussed in the Commission's September 26 order.

4. That the parties shall file a Stipulation and Agreement, or a pleading informing the Commission of the status of their negotiations, by no later than December 12, 1997.
