## ORDER APPROVING INTERIM RATES EFFECTIVE MARCH 1, 1995

On February 17, 1995, Greeley Gas Company (Greeley or Company), A Division of Atmos Energy Corporation, of Denver, Colorado, submitted to this Commission for approval, a tariff sheet which reflects changes in the Purchased Gas Adjustment (PGA) factors resulting from the changes in gas costs incurred from Williams Natural Gas Company (Williams), the Company's major transporter, and to implement two refunds. These refunds amount to approximately \$14,700 plus \$1,300 in interest Greeley will add to the refund amount. The decrease in the regular PGA will have the effect of decreasing annualized revenues by approximately \$4,900. The net effect of these changes will be to decrease annualized revenues by approximately \$20,900.

In its memorandum, the Missouri Public Service Commission Staff (Staff) recommended that interim, subject to refund approval be maintained until the Commission makes its final determination in Case No. GR-94-129. The Staff also stated that one of the refunds contained in this filing was filed beyond the time required as provided for in Company's approved tariffs. The Commission agrees with Staff in reminding Greeley to more closely monitor and adhere to its procedures in the future.

The Commission has reviewed Staff's recommendation and for good cause's shown pursuant to Section 393.140(11) RSMo 1986, is of the opinion that the proposed tariff sheet should be allowed to become effective on and after the requested effective date, March 1, 1995, interim subject to refund.

## IT IS THEREFORE ORDERED:

1. That the following tariff sheet submitted by Greeley Gas Company, A Division of Atmos Energy Corporation, of Denver, Colorado, for the purpose of reflecting changes in gas costs and to implement two refunds be, and it is, hereby authorized to become effective on and after the requested effective date, March 1, 1995, interim subject to refund.
