In an order issued on July 22, 2015, the Commission granted Missouri-American Water Company's application for authority to issue up to \$190,000,000 of long-term unsecured debt. The Commission directed MAWC to submit certain information concerning financial transactions authorized by the Commission's order. On January 18, 2017, MAWC filed notice of the issuance of a promissory note to American Water Capital Corp. in the amount of \$107,480,000. MAWC submitted information to the Commission, as required by the July 22, 2015 order.

The Commission will direct the Commission's Staff to notify the Commission when all information required by the July 22, 2015 order has been provided by MAWC and the Commission may close this file.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall notify the Commission when it is acceptable to close this file.

2. This order shall be effective when issued.
