### THIRD ORDER DIRECTING FILING

On January 18, 2000, the Staff of the Missouri Public Service Commission (Staff and Commission) filed with the Commission a motion to open this case. On September 7, 2000, the Commission ordered the Staff to file a status report, which the Staff did on September 22, 2000. Staff filed on October 24, 2000, a motion for the finding of necessity of rulemaking. On November 2, 2000, the Commission issued its order finding the necessity for rulemaking. On January 9, 2001, the Commission again ordered the Staff to file a status report. On February 8, 2001, Staff filed its status report stating, *inter alia*, that it "expects to complete preparation of [the rulemaking] packet by not later than February 20, 2001." As of the date of this order, Staff has not filed a rulemaking packet.

The Staff will be directed to file a report on the status of this case.

1. That the Staff of the Missouri Public Service Commission shall, no later than March 30, 2001, file with the Missouri Public Service Commission a report on the status of this case.

2. That this order shall become effective on March 5, 2001.
