- That the applicant is a limited liability company duly organized and existing under the laws of the State of Missouri, and has its principal offices and place of business at 382 Mint Lane, Ozark, Missouri 65621. A copy of its Certificate of Organization and Articles of Organization are attached hereto and marked Exhibit A and Exhibit B respectively, and incorporated herein.






