**STAFF'S CONCURRENCE WITH THE AT&T COMPANIES'
MOTION TO SUSPEND AND INVESTIGATE TARIFF**

COMES NOW the Staff of the Missouri Public Service Commission and for its concurrence states:

1. On August 28, 2007, Level 3 Communications filed revised tariff sheets to add Toll Free Data Base Access service, Toll Free Transit Traffic service and rates for Originating Access and Pay Telephone compensation. The revised tariff sheets bear a proposed effective date of September 27, 2007.

2. On September 19, 2007, the AT&T Companies filed a motion requesting the Commission to suspend and investigate the tariff. The motion explains that the tariffs for these proposed new services are vague and ambiguous.

3. The Staff concurs that the revised tariff sheets are vague and ambiguous.

WHEREFORE, the Staff supports the AT&T Companies' request to suspend and investigate Level 3 Communications' revised tariff sheets.
