**STAFF'S MOTION TO EXTEND DEADLINE
TO FILE RECOMMENDATION AND MEMORANDUM**

COMES NOW the Staff of the Missouri Public Service Commission, by and through its attorney and, for its Motion to Extend Deadline to File Recommendation and Memorandum, states to the Commission as follows:

1. On July 28, 2005, the Commission issued its Order Denying Application for Rehearing and Granting a Temporary Waiver. In its order, the Commission directed the Staff to file, by no later than August 4, 2005, a “recommendation and memorandum regarding the requirement of 4 CSR 240-29.040(4) that the originating Calling Party Number (CPN) be included in the 11-01-XX billing records for wireless-originated calls.”

2. The Staff has been working diligently on the preparation of the subject recommendation and memorandum, but, due to the press of other business, will not be able to complete and file the report on August 4, as directed. A complete initial draft of the recommendation and memorandum has been prepared and circulated among members of the Staff who are assigned to this case, and comments and suggestions for change have been provided. However the Staff requires additional time to fully discuss these suggestions and to make any necessary changes to the draft recommendation and memorandum prior to filing it.

The Staff expects that it will be able to complete and file the recommendation and memorandum by no later than Wednesday, August 10, 2005.

3. Rule 4 CSR 240-2.050 (3) provides that when an act is required to be done by order of the Commission at or within a specified time, the Commission, at its discretion, may order the period enlarged before the expiration of the period originally prescribed.

WHEREFORE, the Staff respectfully requests that the Commission extend the deadline for filing the Staff's recommendation and memorandum to Wednesday, August 10, 2005.
