

Proposed Public Service Commission Rule Amendment: 4 CSR 240-32.190

We have reviewed the Public Service Commission's (PSC's) proposed amendment to 4 CSR 240-32.190. This rulemaking will place incumbent local exchange carriers on a level playing field with competitive local exchange carriers and wireless companies by eliminating the regulatory provision prohibiting telecommunications companies from providing per-line blocking to any entity or person.

No legal issues are raised by these proposed rules, nor is there anything controversial about the proposals, to our knowledge. None of the proposed rules will cost affected state agencies or political subdivisions more than \$500 in the aggregate. The fiscal impact on telecommunications companies is projected to be \$0 because the proposed rulemaking does not require companies to take any action. Instead, it removes a restriction and gives companies greater flexibility.

The following documents are enclosed: (1) a letter from the PSC dated October 14, 2010, asking us to review and complete cost affidavits for this rulemaking; (2) a copy of the proposed rule; (3) a small business impact statement for the proposed rule; (4) a fiscal note detailing the private cost of the rule; and (5) an affidavit of public cost for your signature. If this rule amendment meets with your approval, please sign the enclosed affidavit and return it to Victoria Webster so she may forward it to the PSC. Thank you.

The Public Service Commission proposes to publish a Proposed Rule, 4 CSR 240-32.190 Standards for Providing Caller Identification Blocking Service. This amendment removes the prohibition against offering per-line call blocking to the general public.

Adopting the proposed rulemaking does not implicate the takings clause of the U.S. Constitution, because the proposed rulemaking does not involve the taking of real property.

The Commission has performed the small business analysis required by Section 536.300, RSMo Cumm. Supp. 2009, and includes the small business impact statement with this filing. Proposed Rule 4 CSR 240-32.190 does not impose any requirement that "will cause direct and significant economic burden upon a small business, or that is directly related to the formation, operation, or expansion of a small business." The Commission certifies that is has determined that the proposed amendment will not have an economic impact on small businesses.

PROPOSED AMENDMENT

4 CSR 240-32.190 Standards for Providing Caller Identification Blocking Service The secretary is amending section (2).

PURPOSE: This amendment removes the prohibition against offering per-line call blocking to the general public.

(2) All telecommunications companies shall provide per-line blocking for federal, state, and local law enforcement agencies and private, nonprofit, tax-exempt domestic violence intervention agencies, and the employees of these agencies who have a need for such blocking pursuant to their employment. A telecommunications company shall enable perline blocking within a reasonable time after a request from such an agency. A telecommunications company may determine whether the request has been made by a law enforcement or domestic violence intervention agency. [No telecommunications company shall knowingly provide per line blocking to any other entity or person.]

PUBLIC COST: Adoption of this proposed rule will not cost affected state agencies or political subdivisions more than \$500 in the aggregate.

PRIVATE COST: Adoption of this proposed rule will not cost affected private entities more than \$500 in the aggregate.
