ORDER APPROVING TARIFFS

On March 17, 1995, the Missouri Public Service Commission (Commission) issued an Order Granting Certificate of Convenience and Necessity and Approving Financing, granting to applicant Foxfire Utility Company (Foxfire) a certificate of convenience and necessity authorizing it to construct, install, own, acquire, operate, control, manage, and maintain a water and sewer system for the public located in an unincorporated area in Stone County, Missouri. The Commission's order also authorized Foxfire to file separate complete tariffs for the provision of water and sewer service consistent with the proposed tariffed rates which were attached as Attachment No. 2 to the Commission's order. On March 23, 1995, Foxfire filed its tariff schedules pursuant to the Commission's order.

The Commission's Staff filed its recommendation on April 14, 1995. Staff indicates that it has reviewed Foxfire's tariff filings, and that on April 13, 1995, Foxfire submitted substitute sheets for both tariff filings at the request of Staff, to correct some typographical errors and make some other revisions which the Staff had requested. Staff states that the tariff filings are complete, reasonable, and comply with the Commission's order. In addition, Staff points out that the tariffs are similar to those on file for other utilities with which the owners of Foxfire are involved. Staff also notes that Foxfire has requested expedited treatment to allow the tariffs to become effective earlier than the filed effective date. In conclusion, Staff

recommends that the Commission approve the tariff schedules filed by Foxfire to become effective April 24, 1995, or earlier.

The Commission has reviewed the tariff sheets filed by Foxfire, along with the Commission's prior order and Staff's recommendation and is of the opinion that the tariff sheets are in compliance with the Commission's order of March 17, 1995. The Commission finds that the Staff's recommendation is appropriate, and that the tariff filings are just and reasonable. Thus, the Commission approves the tariff filings of Foxfire Utility Company effective April 20, 1995.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets with respect to water service filed by Foxfire Utility Company on March 23, 1995, as substituted on April 13, 1995, be and are hereby approved to become effective April 20, 1995:


