REQUEST FOR EXTENSION OF TIME

(and Response to Proposed Notice of Deficiency)

COMES NOW U. S. WATER COMPANY a Missouri corporation in good standing, by and through the undersigned attorney, and hereby renews its requests for an extension of time with which to file its Annual Report, and in support thereof states the following:

- 1) The Company, a small private water utility, previously requested an extension for its 2006 Annual Report, however several unintended deficiencies were noted.
- 2) The Company is in the process of assembling the data necessary for its Annual Report. The Company acted in good faith in submitting a request for extension of time on April 16th, 2007 as April 15th, 2007 occurred on a Sunday this year.
- 3) The Company did not request an extension of time last year. U.S. Water Co. will not initiate any other action before the Commission prior to, or simultaneously with, the submittal of its Annual Report. This request is not being made to hinder or delay the Public Service Commission.
- 4) To the best of its knowledge, the Company does not have any pending actions or unsatisfied judgments of decisions against it involving customer service or rates during the past three (3) years.
- 5) The Company agrees to pay the initial \$100.00 penalty but hereby requests a waiver and relief from other charges and penalties.

WHEREFORE, U. S. WATER COMPANY, for good cause shown, hereby respectfully requests a waiver of the per diem penalty and a waiver or variance of any other requirements of 4 CSR 3.640 and 4 CSR 240.2.080 to allow the granting of a sixty (60) day extension of time to file its annual report.
