On September 15, 2021, the Commission directed its Staff (Staff) to file a recommendation by October 28, 2021, on Missouri-American Water Company's (MAWC's) *Application and Motion for Waiver*, requesting authority to issue long-term debt. Staff filed its recommendation on October 28, 2021.

On November 5, 2021, MAWC filed a *Motion for Extension* requesting an extension of time to November 22, 2021, to file its response to Staff's recommendation. MAWC cited the need for additional time to discuss with Staff several of the conditions contained in Staff's recommendation to gain a better understanding of the conditions and to make a meaningful response. Staff does not oppose the motion.

The Commission finds the motion reasonable and will grant it.
