## ORDER ESTABLISHING DEADLINE FOR FILING STIPULATION AND AGREEMENT OR REVISED PROCEDURAL SCHEDULE AND SUSPENDING DEADLINE FOR RESPONSES

On November 5, 1997, the Trustees of Incline Village (Trustees) filed a motion to suspend procedural schedule and establish deadline for filing stipulation or revised procedural schedule. The Trustees state that the Applicant<sup>1</sup> and the Trustees are presently engaged in settlement negotiations in an attempt to settle and resolve the issues before the Commission in this proceeding. The parties are in the process of reducing their settlement negotiations to a Settlement Agreement and Stipulation. Trustees state t.hat. it. would be inefficient and potentially counterproductive to prepare and file responses to Applicant's pending motions while at the same time negotiating and drafting a Settlement Agreement and Stipulation. Trustees request that the Commission suspend the procedural schedule and response deadline until December 3 and that the Commission further establish a deadline of December 3 for filing a

stipulation or a revised procedural schedule. Trustees state that all of the parties to this docket have expressed their consent to this request.

The Commission has reviewed the motion and determines that the relief requested is reasonable and that it should be granted.

## IT IS THEREFORE ORDERED:

- 1. That the Motion to Suspend Procedural Schedule and Establish Deadline for Filing Stipulation or Revised Procedural Schedule filed by the Trustees of Incline Village on November 5, 1997, is granted.
- 2. That the procedural schedule in this case is suspended and the hearing set for December 1, 2 and 3, 1997, is canceled.
- 3. That the parties shall file a stipulation and agreement or revised proposed procedural schedule no later than December 3, 1997.
- 4. That this order shall become effective on November 10, 1997.
