**ORDER APPROVING TARIFF SHEETS FILED  
IN COMPLIANCE WITH STIPULATION AND AGREEMENT**

On July 1, 1997, Union Electric Company (UE) of St. Louis, Missouri filed tariff sheets (File No. 9700878) concurrently with the filing of the Stipulation And Agreement in this case. On July 23, UE withdrew the tariff sheets referred to in the immediately preceding sentence.

On July 18, the Commission issued an Order Approving Stipulation And Agreement in this docket. On July 23 UE filed tariff sheets, a sample bill insert designed to explain changes to the Purchased Gas Adjustment (PGA) clause to customers, and a sample bill format designed to reflect the volumes used and the prices charged under the PGA clause pursuant to the Commission's order.

On July 25 the Staff of the Missouri Public Service Commission (Staff) filed a memorandum to the official case file. Staff notes that as a result of conversations between Staff and UE, the effective dates were changed from August 1 to October 5 for all the tariff sheets except Sheet No. 29.4, which contains the Experimental Price Stabilization Fund.

Staff states that it has reviewed the tariff sheets and has determined that they reflect substantially the same form as those attached to the Stipulation And Agreement.

The Commission has reviewed the proposed tariff sheets and the Staff's recommendation. The Commission finds that the proposed tariff sheets comply with the Commission's order.

**IT IS THEREFORE ORDERED:**

1. That the following tariff sheet shall be approved for service rendered on and after August 1, 1997.


