**ORDER APPROVING TARIFFS IN COMPLIANCE WITH A COMMISSION ORDER**

On August 27, 1997, the Commission issued its order granting a certificate of convenience and necessity to Cannon Home Association, Inc. (CHA) providing, among other matters, that CHA should file tariffs in accordance with the Commission's order. On September 18, CHA filed tariffs purporting to be in full compliance with the Commission's order in this matter. These proposed tariffs bear an effective date of October 22.

On September 29, the Staff of the Commission (Staff) filed its recommendation in this matter stating that, after review, it is the opinion of the Staff that all aspects of the proposed tariffs, including the proposed rates and service area, are in compliance with the requirements of the Commission's order of August 27. The Staff recommends approval of the tariffs.

The Commission has reviewed the proposed tariffs and Staff recommendation and finds the proposed tariffs to be reasonable and in full compliance with the Commission's order of August 27. The Commission will approve the proposed tariffs for service on or after October 22.

**IT IS THEREFORE ORDERED:**

1. That the following tariffs, filed September 18, 1997 by Cannon Home Association, Inc., are hereby approved for service on or after October 22, 1997:


