**ORDER APPROVING TARIFF SHEETS FILED IN COMPLIANCE**  
**WITH REPORT AND ORDER**

On April 4, 1997, the Commission issued a Report and Order in this case. In that order the Commission ordered House Springs Sewer Company (House Springs) to file tariff changes to implement the rate reductions contemplated in a Unanimous Stipulation and Agreement which was filed by Imperial Utility Corporation, House Springs, the Staff of the Missouri Public Service Commission (Staff) and the Office of the Public Counsel (Public Counsel). The Unanimous Stipulation and Agreement was approved by the Commission. Pursuant to the terms of the agreement House Springs is to phase in rate reductions in three steps effective August 1, 1997, August 1, 1998, and August 1, 1999. The Unanimous Stipulation and Agreement states that the rate reductions are to be phased in effective July 1, 1997, July 1, 1998, and July 1, 1999. However, the parties stipulated at hearing that the July 1 dates with regard to House Springs were typographical errors and those dates should be August 1 of 1997, 1998 and 1999.

On July 31 House Springs filed revised tariff sheets which reflect the agreed-upon rate change. On July 31 Staff filed a memorandum to the official case file. Staff states that the tariff change is

consistent with the terms of the Unanimous Stipulation and Agreement and that the effect of the change is to decrease House Spring's annual revenues by approximately \$5,769. Staff states that it has reviewed the tariff sheets and finds that they comply with the Commission's Report and Order in this case. Staff demonstrates that the tariff change implements a change in monthly residential bills from \$23.50 to \$22.00 and that this is a decrease of approximately six percent. Staff recommends that the Commission approve the proposed tariff sheets for service rendered on and after August 1, 1997.

The Commission has reviewed the Report and Order, Unanimous Stipulation and Agreement, proposed tariff sheets and Staff's memorandum in this case. The Commission finds that the proposed tariff sheets comply with the Report and Order and that they should be approved.

**IT IS THEREFORE ORDERED:**

1. That the following tariff sheets of House Springs Sewer Company are hereby approved for service rendered on and after August 1, 1997.


