ORDER APPROVING TARIFFS

On January 14, 1994, Laclede Gas Company (LGC) filed proposed tariff sheets reflecting increased rates for gas service provided to customers in its Missouri service area. The Commission issued its Report and Order in this matter on August 22, 1994 approving a Stipulation and Agreement and ordering LGC to file tariffs in accordance with the Stipulation and Agreement, for service on or after September 1, 1994.

On August 25, 1994, LGC filed tariffs with an effective date of September 1, 1994. The filed tariff sheets are designed to increase annual gas revenues by approximately \$12.2 million in accordance with the above-stated Stipulation and Agreement. The Staff of the Commission has reviewed these tariffs and filed its recommendation on August 26, 1994.

In that recommendation the Staff stated that, in addition to the general rate increase modifications, other tariff sheets reflect the remainder of the matters agreed to in the Stipulation and Agreement.

The Staff stated that it had reviewed the instant tariff sheets and was of the opinion that they are in compliance with the Commission's order of August 22, 1994. The Staff recommended approval of the instant tariffs, for service on or after September 1, 1994.

The Commission has reviewed the LGC tariff filing and the Staff's recommendation and finds the instant tariffs to be in compliance with the Commission's order and the approved Stipulation and Agreement in this case and

will, therefore, approve the tariff sheets, filed by LGC on August 25, 1994, for service on or after September 1, 1994.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets, filed by Laclede Gas Company on August 25, 1994, are reasonable and will be approved for service on or after September 1, 1994.
