ORDER SETTING PROCEDURAL CONFERENCE

On May 6, 2021, Missouri-American Water Company (MAWC) and DCM Land, LLC, filed an application for a variance from provisions of MAWC's tariffs with regard to the connection time and funding percentage for an extension of MAWC's water main into the Cottleville Trails development. Subsequently, the Staff of the Commission filed its recommendation that the Commission reject the application. MAWC and DCM Land, LLC, responded in opposition to that recommendation. The Commission will direct the parties to meet in a procedural conference and to file a proposed procedural schedule.

THE COMMISSION ORDERS THAT:

1. The parties shall appear at an electronic procedural conference to be held on September 1, 2021, at 1:30 p.m. The procedural conference will be held electronically with all parties, including the presiding officer, participating by video or telephone. The link and access code to participate in the conference will be emailed to all parties.
2. No later than September 3, 2021, the parties shall file joint or individual proposed procedural schedules.

3. This order is effective when issued.
