withdraws its intervention in this matter. SWBT's withdrawal of intervention is based upon the
representation of counsel for Metromedia Fiber Network Services, Inc. (MFN) that MFN is not
seeking a certificate of service authority to provide basic local telecommunications service, but
rather is seeking authority to provide only nonswitched local exchange and interexchange
service.


