STATUS REPORT

Charter Fiberlink-Missouri, LLC ("Charter" or "Company") states the following:

1. On November 18, 2004, the Commission granted Charter's request to review and reverse the decision of the North American Numbering Plan Administrator ("NANPA") to deny Charter's requests to receive an NPA/NXX code of 10,000 telephone numbers for the Wentzville and Pacific Rate Centers, respectively. The Commission directed NANPA to issue Charter one block of 10,000 numbers in each of these rate centers, but directed Charter to return 9,000 of the numbers in each rate center, consistent with Charter's request that it ultimately receive 1,000 numbers per rate center.

2. Since the Commission's November 18, 2004 Order, Charter has carried out those directives, and hereby reports fully to the Commission on the details of such actions. This filing is made in compliance with the Commission's subsequent orders of March 2, 2005, and April 20, 2005, directing Charter to file a status report.

3. Charter has attached to this Status Report the Affidavit of Mary Daudelin, Regulatory Director, who is familiar with the process that the Company followed to obtain the numbers for the Wentzville and Pacific Rate Centers. She describes in detail the Company's request of December 1, 2004 to seek the block of numbers for the Pacific

Rate Center, and the response of the Pooling Administration System on December 14, 2004. See Affidavit of Mary Daudelin, paragraphs 3-4. Appended to her Affidavit are copies of the appropriate reports, including the Pooling Administration Part 3 form, which verified the return of the unused telephone numbers to the Pool. Similarly, paragraphs 5-6 of the Affidavit describe the process that was followed to obtain the block of numbers for the Wentzville Rate Center.

4. Paragraph 7 of Ms. Daudelin's Affidavit describes the "Assigned Blocks" and "Available Blocks" reports issued by the Pooling Administrator, which confirm that Charter was assigned 1,000 numbers for the Pacific and Wentzville Rate Centers, respectively.

5. Ms. Daudelin's Affidavit and the attached documentation fully comply with the Commission's Orders of both March 2, 2005 and April 20, 2005.

WHEREFORE, Charter FiberLink-Missouri LLC requests that these filings be accepted and that the Commission issues its Order closing this case.
