VERFIED STATEMENT

COMES NOW, Union Electric Company d/b/a AmerenUE ("Company"), a Missouri corporation, in response to an Order and Notice and Order Directing Filing dated July 5, 2006 of the Missouri Public Service Commission ("Commission"), states as follows:

- 1. Company is a corporation organized and existing under the laws of the State of Missouri, in good standing in all respects, with its principal office and place of business located at One Ameren Plaza, 1901 Chouteau Avenue, St. Louis, Missouri 63103. Company is an electrical corporation subject to the jurisdiction of the Commission and engaged in the sale and distribution of electricity in portions of Missouri, including the area in and around 3384 Bainbridge Road, Jackson, Missouri 63755.

- 3. Case No. EO-2006-0553 involves an application by Mr. Steve Jones ("Jones") for Commission approval of a change of its electric service provider from Company to Jackson Electric Distribution Department ("Jackson").
- 4. In support of his Application, Jones states that "[t]he AmerenUE service line which supplies power to our property is surrounded by Jackson Electric Distribution Department service lines. The city is in the construction of a road project, which will require lines to be relocated." Application of Steve Jones at 1. Company admits that this assertion is correct.
- 5. Jones further states "Transferring service" from Company to Jackson "will help the city and the project being constructed and will not adversely affect me." Application of Steve Jones at 1. Company has no knowledge regarding this assertion.
- 6. In a letter dated June 28, 2006, Smith Co. Engineers, a contractor for Jackson, states Jackson's and Company's power line in the vicinity of Jones' residence cross one another in several places, share poles, and as a result create a safety and service hazard.

 Company admits that these facts and the ultimate conclusion are correct.
- 5. The Company recommends the Commission approve this requested change in electric supplier as being in the public interest for reasons other than rate differential.

 Notwithstanding the foregoing, Company request that in its Order (i) require the Company to cut open the facilities serving Jones' residence, (ii) require Jackson to return to Company any and all

transformers associated with Jones' existing service, and (iii) require Jackson take title to all existing facilities serving Jones' residence after said facilities are cut open by Company. The last provision is requested to permit Jackson to obtain maximum use of the existing facilities and to limit Company's ongoing liability.
