- 1. The St. Joseph Water Rate Coalition ("St. Joseph WRC") filed its Application to Intervene in this proceeding on June 18, 2003. Although that Application has not yet been granted, the Commission ordered in its Suspension Order and Notice that Staff, the Office of the Public Counsel, and any persons or entities requesting intervention must file on or before June 24 a pleading indicating their position with regard to the test year and true-up recommended by Missouri-American Water Co. ("MAWC").
- 2. In the Direct Testimony of Edward J. Grubb, MAWC proposed a historical test year ending December 31, 2002, and a true-up as of November 30, 2003.
  - 3. St. Joseph WRC concurs in this recommendation.

WHEREFORE, the St. Joseph Water Rate Coalition requests that the test year and trueup proposal of Missouri-American Water Co. be accepted.
