Our client, France Telecom Corporate Solutions L.L.C. ("FTCS"), is a CLEC authorized to provide services in Missouri under Case No. LA-2005-0193. FTCS operates on a "pure resale" basis, *i.e.*, it does not own or control any telecommunication facilities, and it does not purchase unbundled network elements.

Because FTCS is a non-facilities based provider, it does not provide access services, it does not collect access charges, and it does not have an access tariff on file with the Commission.

As such, we believe that your Order in Case No. TT-2012-0317 referencing updating FTCS' tariff to conform with the FCC's USF-ICC Reform Order are not applicable.
