**APPLICATION FOR APPROVAL OF TWO AMENDMENTS TO AN
INTERCONNECTION AGREEMENT**

COMES NOW TMP CORP. ("TMP" or "Applicant") by its undersigned counsel, pursuant to 4 CSR 240-2.060 and 4 CSR 240-3.513(6)(c) and hereby files its Application for Approval of two amendments to a previously approved Interconnection Agreement between Applicant and Southwestern Bell Telephone, L.P. d/b/a SBC Missouri ("SBC Missouri"), whose current fictitious name as recognized by the Commission in IN-2006-0232 is AT&T Missouri. In support of this Application, TMP states as follows:

1. Applicant is a provider of Commercial Mobile Radio Service (CMRS) under licensing of the Federal Communications Commission. The nature of Applicant's business is the provision of cellular telecommunications services. Applicant is an Illinois corporation with its principal place of business at 405 Emminga Rd., Golden IL 62339. Applicant's authority to transact business in Missouri from the Secretary of State's Office is attached hereto as Exhibit 1. The telephone number, fax and email address for applicant are:

2. Applicant states, in accordance with 4 CSR 240-2.060(1)(K), that there are no pending actions or final unsatisfied judgments or decisions against Applicant in any state, federal agency or court which involve customer service or rates for which action, judgment or decision has occurred within three (3) years of the date of this Application.

3. Pursuant to 4 CSR 240 240-2.060(1) (L), Applicant states that the Company does not have any overdue annual reports or assessment fees owed to the Commission.

4. Southwestern Bell Telephone, L.P., d/b/a SBC Missouri, is an Incumbent Local Exchange Carrier (ILEC) and is now doing business in Missouri as AT&T Missouri. SBC Missouri is a Texas limited partnership with its principal offices in Missouri located at One AT&T Center, Room 3520, St. Louis, Missouri 63101. SBC Missouri adopted a new fictitious name in Missouri subsequent to execution of this Agreement, "AT&T Missouri", as authorized by the Commission in Case No. IN-2006-0232. This change in fictitious name does not alter the identity of the parties to the agreement.

6. The Commission approved the original agreement between SBC Missouri and TMP on July 15, 2002, in Case No. TK-2002-1095. The original agreement was amended in May 2006, in VT-2006-0039 pursuant to 4 CSR 240-3.513(6)(A)'s expedited process for previously approved amendments. Two additional amendments have been agreed to by Applicant and AT&T Missouri; these amendments do not appear to qualify as "Amendments previously approved by the Commission" for any other interconnection agreements. Thus, pursuant to 4 CSR 240-3.513(6)(C), Applicant presents to this Commission two amendments to the Interconnection Agreement for approval. The amendments will be submitted as separate files in the Commission's Electronic Filing Information System. The first amendment is designed to revise the InterMTA Traffic Rate. It is a three-page amendment, and is labeled in the top right corner of the first page "Amendment -- Change InterMTA Rates". The second amendment is designed to change the Shared Facility Factor. It is also a three-page amendment, and is labeled in the top right corner of the first page "Amendment -- Change Shared Facility Factor". These Amendments result from negotiations between SBC Missouri and TMP, and are not discriminatory against

any telecommunications carrier. They are consistent with the public interest, convenience and necessity. As stated above, to Applicant's knowledge, these particular types of interconnection agreement amendments have not been previously approved by the Commission, prompting this Application pursuant to 4 CSR 240-3.513(6)(C). Applicant's officer's verification will be late-filed.

WHEREFORE, for the foregoing reasons, TMP Corporation respectfully requests that the Commission approve the two Amendments to the Interconnection Agreement between TMP Corporation and SBC Missouri; namely "Amendment—Change InterMTA Rates" and "Amendment – Change Shared Facility Factor".

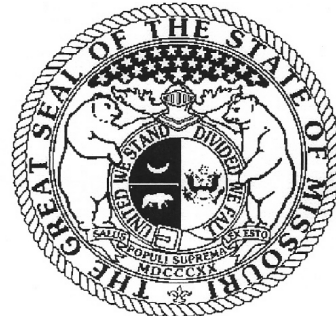
