ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFFS

On November 11, 2011, Mercury Voice and Data Company filed notification of its change of corporate name to “Mercury Voice and Data, LLC, d/b/a Suddenlink Communications” and new tariff sheets reflecting the name change. The tariffs have an effective date of November 21, 2011.

The Staff of the Missouri Public Service Commission filed a verified recommendation on November 18, 2011. Staff recommends that the Commission recognize the new name. Staff states that the company’s application complies with the filing requirements in Rule 4 CSR 240-2.060, no entities intervened to oppose the name change, the company is not delinquent in any required filings with the Commission, and the filed tariff adoption notices are compliant with Commission rules.

The Commission has reviewed the application and Staff's recommendation. The Commission finds that the name change shall be recognized and the proposed tariff sheets shall be approved.
