**ORDER GRANTING WAIVER OF COMPLIANCE
WITH A PORTION OF A COMMISSION ORDER**

Issue Date: February 2, 2022

Effective Date: February 12, 2022

On December 8, 2021, the Commission issued its *Order Approving Stipulation and Agreement, Asset Transfer, and Certificates of Convenience and Necessity*, effective December 18, 2021 (the "Approval Order"). Paragraph 3(k) of the Approval Order requires Liberty Utilities (Missouri Water) LLC (Liberty) to provide the Customer Experience Department (CXD) Staff with a sample of ten billing statements from the first month's billing within thirty days of closing on certain water and sewer assets in Polk County, Missouri. On January 20, 2022, Liberty filed a motion for partial waiver or modification of paragraph 3(k) of the approval order, explaining that the closing on those assets is scheduled to be effective on February 1, 2022, and that the first billing statements will not be mailed out until about March 7, 2022. Liberty seeks to extend the time required for filing sample billing statements until March 15, 2022, exceeding the time required in the Approval Order by thirteen days.

On January 20, 2022, Staff filed its recommendation, advising the Commission to grant Liberty's motion. The Commission finds Liberty's motion reasonable and will grant it. The Commission also finds it reasonable for this Order to be effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. Liberty is relieved from the obligation to submit sample billing statements to the CXD staff under paragraph 3(k) of the Approval order.
2. Liberty shall provide to the CXD staff a sample of ten billing statements from the first month's billing no later than March 15, 2022.
3. This order shall be effective on February 12, 2022.
