ORDER DIRECTING STAFF'S RECOMMENDATION

On December 8, 2021, the Commission issued its *Order Approving Stipulation and Agreement, Asset Transfer, and Certificates of Convenience and Necessity* (Order). Ordered paragraph 3(k) of that Order requires Liberty to submit sample billing statements to the Commission's Customer Experience Department within 30 days of closing on certain assets in Polk County, Missouri.

On January 20, 2022, Liberty filed its *Status Report and Motion for Partial Waiver or Modification*, stating that the closing should occur on February 1, 2022, but that it will not issue its first billing statements until about March 7, 2022, exceeding the time prescribed in the Order. Liberty seeks partial waiver or modification of the Order, allowing it to submit the sample statements by March 15, 2022.

The Commission will order Staff to file a recommendation regarding Liberty's motion for partial waiver or modification.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation on the motion for partial waiver or modification submitted by Liberty no later than February 1, 2022.

2. This order shall be effective when issued.
