On April 26, 2021, Missouri-American Water Company (MAWC) filed applications with the Commission requesting Certificates of Convenience and Necessity to install, own, acquire, construct, operate, control, manage, and maintain a water system and a sewer system in the City of Eureka, Missouri and the surrounding area.

On October 1, 2021, the Staff of the Commission (Staff) filed its recommendation to the Commission regarding the applications.

Both the water and sewer applications refer to a "Valuation Report" attached to the applications as Appendix A. The Valuation Report, in turn, refers to a "Flinn Engineering report" dated March 16, 2020, stating that it is attached to the valuation report. Staff's recommendation also refers to the Flinn Engineering report and indicates that they reviewed more than one version of the report. In reviewing the documents filed in this matter, the Commission does not find any Flinn Engineering reports. The Commission will order that any and all versions of the report be filed.

THE COMMISSION ORDERS THAT:

1. No later than January 3, 2022, MAWC and Staff shall file any and all versions of the Flinn Engineering report referred to in Appendix A of MAWC's applications, with supporting affidavits.

2. This order shall be effective when issued.
