ORDER DIRECTING AN EXPEDITED STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On December 15, 2021, the Commission issued its order granting Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) water and sewer certificates of convenience and necessity. On December 16, 2021, Confluence Rivers filed tariff sheets to comply with the Commission's order together with a motion for expedited treatment. Those tariff sheets bear an effective date of January 15, 2022, but Confluence Rivers has requested that the Commission allow those tariff sheets to take effect on December 28, 2021, prior to closing of assets for Cedar Green, Clemstone, The Missing Well, and Spring Branch. In consideration of Confluence Rivers' request the Commission will direct its Staff to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other responses to the tariff sheets or Confluence Rivers' request for expedited treatment.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding the tariff sheets and motion for expedited treatment filed by Confluence Rivers no later than December 21, 2021, at 3:00 p.m.

2. Any other responses to Confluence Rivers' tariff sheets or motion for expedited treatment shall be filed no later than December 21, 2021, at 3:00 p.m.

3. This order is effective when issued.
