ORDER DIRECTING RESPONSE

On July 1, 2022, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application for a certificate of convenience and necessity (CCN) for a water system currently served by Tan Tar A State Road, LLC (Tan Tar A), located in Camden County. The Commission directed the Staff of the Commission (Staff) to provide its recommendation.

Staff's recommendation cites several examples of information Staff has requested, but not received. Staff's recommendation states it is not opposed to this transaction in principle, but is concerned regarding the safe and adequate supply of water. Staff requests the Commission to order Confluence Rivers to produce the requested information.

The Commission will order Confluence Rivers to respond to Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Confluence Rivers shall file its response to Staff's recommendation on or before November 3, 2022.

2. Any other party wishing to respond shall do so on or before November 3, 2022.

3. This order shall be effective when issued.
