On September 9, 2022, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed two applications that sought permission and approval for a certificate of convenience and necessity (CCN) to construct, install, own, operate, maintain, control, and manage a water system and a sewer system, respectively, in an area of St. Charles County, Missouri. Also, on September 9, 2022, Confluence Rivers filed a *Motion to Consolidate* in each case, requesting that the two applications be consolidated, as Confluence Rivers is the applicant in both cases and the water and sewer systems sought to be purchased are currently owned by the same homeowners association. In addition, Confluence Rivers alleges that both cases will contain common questions of law and fact. Should the motion be granted, Confluence Rivers requested that WA-2023-0092 be designated as the lead case.

Commission Rule 20 CSR 4240-2.110(3) allows for the consolidation of cases with related questions of law or fact. Since these two files involve related questions of law and fact, the Commission will grant the motion.
