ORDER GRANTING MOTION TO CONSOLIDATE

On March 14, 2023,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed applications that seeks approval for a certificate of convenience and necessity (CCN) and authority to acquire the unregulated water and sewer systems of Four Seasons North MHP, LLC (Four Seasons).

On March 15, Confluence Rivers filed a *Motion to Consolidate*, requesting that the two CCN applications be consolidated as they have questions of law and fact in common, and the consolidation would simplify the filings to be made. Commission Rules allow that responses can be filed within ten days.² No objections or responses were received.

Commission Rule 20 CSR 4240-2.110(3) allows for the consolidation of cases with related questions of law or fact. Since these cases involve related questions of law and fact, the Commission will grant the uncontested motion.

1. Confluence Rivers' motion to consolidate File Nos. WA-2023-0284 and SA-2023-0285, with File No. WA-2023-0284 being the lead case, is granted.
