**ORDER DIRECTING EXPEDITED STAFF REVIEW**

On July 12, 2023,<sup>1</sup> the Commission issued its *Order Approving Acquisition of Assets and Granting a Certificate of Convenience and Necessity* (Order) granting Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) a certificate of convenience and necessity (CCN) to provide water and sewer service to Four Seasons North MHP, LLC (Four Seasons) located in Johnson County, Missouri.

On August 3, Confluence Rivers filed tariff sheets purporting to be in compliance with the Commission’s Order. Those tariff sheets were assigned Tracking Nos. YW-2024-0019 and YS-2024-0020 and have a proposed effective date of September 2.

The Commission will direct its Staff to review the tariff sheets and provide its recommendation. The Commission will also set a time for other responses.

**THE COMMISSION ORDERS THAT:**

1. No later than August 21, Staff shall file a recommendation as directed in the body of this order or a statement of when it expects to file its recommendation.
