On June 30, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed the above-referenced applications. The applications seek, among other things, authority for Confluence to acquire and operate the sewer systems of Brussels Valley Estates, Inc., and Mapaville Meadows. Confluence also wishes to acquire and operate the water and sewer systems of Chevron/Sierra Land Company, LLC. Confluence seeks certificates of convenience and necessity to operate those systems.

The Commission ordered its Staff to file a Recommendation or Status Report no later than August 28, 2023. On that date, Staff filed a Status Report, stating that it expects to file its Recommendation no later than October 28, 2023. Thus, the Commission will order its Staff to do so.

1. The Commission's Staff shall file a Recommendation no later than October 28, 2023.
