**ORDER DIRECTING FILING
RESPONSE CLARIFYING AND CITING AUTHORITY**

On October 16, 2001, Respondents filed a Third-Party Petition requesting that the Commission enter an order upholding a May 18, 2001 agreement between Complainants and P.B. Real Estate L.L.C. In their petition, respondents further declared that the presence of P.B. Real Estate in this action is necessary for the full and fair adjudication of this complaint.

It is well established that the Commission does not enforce contracts between non-regulated private parties, nor does the Commission generally assume jurisdiction over non-regulated third-parties. In light of this knowledge, the Commission is interested to hear Respondents' clarification and justification of their Third-Party Petition requests and, in doing so, Respondents shall cite the proper authority upon which these requests are based.

Respondents' prompt reply to this Order is essential for the Commission's evaluation of the Third-Party Petition. Accordingly, the Commission directs Respondents to file a response clarifying their requests and to cite the authority upon which they are based.

IT IS THEREFORE ORDERED:

1. That Respondents file a response clarifying their requests and citing the authority upon which they are based not later than Friday, November 2, 2001.
2. That this order shall become effective on October 26, 2001.

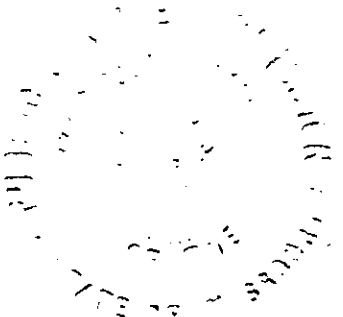
