MISSOURI GAS ENERGY’S MOTION FOR TEMPORARY STAY
PENDING SETTLEMENT DISCUSSIONS

COMES NOW Missouri Gas Energy, a Division of Southern Union Company (“MGE” or Respondent”), by and through counsel, and for its motion for a temporary stay pending settlement discussions of the Complaint filed by Vandora R.
