ORDER APPROVING INTERIM RATES EFFECTIVE JANUARY 21, 1995

On January 6, 1995, Laclede Gas Company (Laclede or Company) of St. Louis, Missouri, filed for approval, a tariff sheet which reflects a change in the Purchased Gas Adjustment (PGA) factors due to changes in Laclede's cost of gas. Additionally the Capacity Reservation factor will change for Company's Firm transportation customers. The effect of these PGA changes will be to decrease annualized revenues by approximately \$7 million.

Case No. GR-95-159, under which this Laclede change was filed, was established to address Laclede's PGA factors contained in its 1994-1995 Actual Cost Adjustment (ACA) filing. Case Nos. GR-93-149 and GR-94-150 were established to address Laclede's PGA factors that will be reviewed in its 1992-1993 and 1993-1994 ACA filings, respectively.

The Missouri Public Service Commission Staff (Staff) is of the opinion that the proposed changes comply with the current PGA clause. Additionally, Staff recommends the proposed tariff sheet be approved, interim subject to refund, pending final Commission decisions in Case Nos. GR-93-149 and GR-94-150.

The Commission has reviewed Staff's recommendation and for good cause shown pursuant to Section 393.140(11) RSMo 1986, the Commission is of the opinion that the proposed tariff sheet should be allowed to become effective on the requested effective date of January 21, 1995, interim subject to refund.

IT IS THEREFORE ORDERED:

1. That the following tariff sheet submitted January 6, 1995, by Laclede Gas Company of St. Louis, Missouri, for the purpose of reflecting a change in rates for its natural gas and Firm transportation service, be and it is hereby authorized to become effective on and after January 21, 1995, interim subject to refund.
