ORDER APPROVING TARIFF SHEETS

On November 29, 1994, the Commission issued its Order Approving Agreement in this case. The Commission also directed Missouri American Water Company (company) to file tariff sheets consistent with the approved agreement and with the Commission's Order within ten days of the order's effective date of December 9, 1994. The company failed to requesting an extension of time or to file the required tariff sheets within ten days. On February 3, 1995, the company filed its tariff sheets, and on February 24, 1995, filed substitute sheets to incorporate a suggestion from the Staff of the Missouri Public Service Commission (Staff).

On February 27, 1995, Staff filed a memorandum giving its recommendation. Staff stated that it had reviewed the proposed tariff sheets and concluded that the tariff sheets filed are consistent with the approved agreement and in compliance with the Commission order. Staff also stated that the tariff sheets included modifications of tariff language designed to bring the company's tariff into compliance with recent changes to the Code of State Regulations. In particular, the tariff language was modified to comply with 4 CSR 240-13.015 (definitions), 4 CSR 240-13.030 (deposits and guarantees of payment), and 4 CSR 240-13.050 (discontinuance of service). Staff recommended that the tariff sheets be approved, as amended, to go into effect on March 8, 1995.

Having reviewed the company's tariff sheets and Staff's recommendation, the Commission finds that the company's proposed tariff sheets are in compliance with the approved agreement, with applicable Commission rules and with the Commission's Order Approving Agreement. The Commission further finds that the proposed tariff sheets filed on February 3, 1995, and amended on February 24, 1995, should be approved to become effective on March 8, 1995.

IT IS THEREFORE ORDERED:

1. That the tariff sheets filed by Missouri American Water Company on February 3, 1995, be approved, as amended, to become effective on March 8, 1995. The tariff sheets approved are:
