**COMES NOW** Missouri-American Water Company (MAWC) and, as its *Eleventh Status Report*, states as follows to the Missouri Public Service Commission (Commission):

1. On June 5, 2020, the Commission issued its *Order Amending Status Report Schedule*, wherein it directed that MAWC file status reports every three months.
2. The asset ownership issues have not been resolved as of this date. The litigation involving the Isla del Sol Condominium Association, Inc. and Rockwood Bank continues.<sup>1</sup>
3. MAWC will file its next status report on or about June 1, 2020, unless the ownership interest is resolved prior to that date.


