On October 15, 2020, Liberty Utilities (Missouri Water) LLC, d/b/a Liberty Utilities (Liberty) filed its application for Certificates of Necessity (CCN) authorizing it to install, own, acquire, construct, operate, control, manage, and maintain a water system and a sewer system in Bolivar, Polk County, Missouri. On April 16, 2021, the Commission’s Staff filed its Recommendation, and on April 26, 2021, Liberty filed its Response to Staff Recommendation and Request for Ruling (Response). After reviewing Staff’s recommendation and Liberty’s response, the Commission has determined that a procedural conference should be conducted. The Commission will schedule a procedural conference. Because of the continuing COVID19 pandemic, the conference will be conducted via Webex.

THE COMMISSION ORDERS THAT:
