## STAFF RECOMMENDATION

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through the undersigned counsel, and for its Staff Recommendation states to the Missouri Public Service Commission as follows:

- 1. On April 7, 2014,<sup>1</sup> Ozark Shores Water Company ("Company") filed an *Application* to request the Commission extend the time for filing its calendar year 2013 annual report for its water utility service until June 30.
- 2. On the same date, the Commission ordered Staff to file its recommendation concerning the *Application* by no later than April 11.
- 3. As support for the request, the *Application* states that the Company's auditors are working to compile the necessary information to complete the report, but they are not expected to finish their work in time to meet the April 15 deadline established by the Commission's rules.
- 4. Section 393.140 (6), RSMo 2000, provides that every water corporation under the supervision of the Commission shall file an annual report.
- 5. Additionally, Rule 4 CSR 240-3.640 provides that every water utility shall submit an annual report by April 15 of each year. However, Section (7) of that rule allows a water utility to request an extension of greater than thirty days by filing a pleading prior to April 15:

- (7) A water utility that is unable to meet the submission date established in section (1) of this rule may request an extension of greater than thirty (30) days for submitting its annual report by:
- (A) Filing a pleading, in compliance with the requirements of Chapter 2 of 4 CSR 240, which states the reason for and the length of the extension being requested, with the commission prior to April 15; and
- (B) Certifying that a copy of the pleading was sent to all parties of record in pending cases before the commission where the utility's activities are the primary focus of the proceedings.
- 6. Upon reviewing the Company's request, Staff recommends the Commission find that the *Application* has met the filing requirements of Chapter 2, in particular, Rule 4 CSR 240-2.060 for applications, and Rule 4 CSR 240-3.640 (7), and that the relief requested is reasonable.

WHEREFORE, Staff respectfully recommends the Commission issue an order that finds Ozark Shores Water Company's *Application* meets the requirements of the Commission's rules and the relief requested therein is reasonable, and extends the time within which the Company shall file its 2013 calendar year annual report to June 30, 2014.
