SECOND CUSTOMER NOTICE

Dear Customer:

On June 9, 2008, West 16th Street Sewer Company, Inc. (Company) submitted a request for a small utility rate case to the Missouri Public Service Commission (Commission). In response to the Company's request, the Staff of the Commission (Staff) conducted an audit of the Company's books and records, and an investigation of the Company's system operations and business operations. Based upon the results of the Staff's audit and investigation, the Company and the Staff have reached an agreement that, if approved by the Commission, would result in an increase of \$6,031 in the Company's annual sewer operating revenues. Set out at the end of this notice is a table that summarizes the proposed revisions to the Company's rates.

The Office of the Public Counsel (OPC), an agency that represents utility consumers before the Commission, has reviewed the results of the Staff's audit and investigation, and the related Company/Staff agreement, but has not yet taken a final position regarding those results or the agreement. Also, depending upon the responses to this notice, the OPC may request that the Commission hold a local public hearing.
