On June 7, 2018, the Carl R. Mills Trust filed an application for a Certificate of Convenience and Necessity to install, own, acquire, construct, operate, control, manage and maintain a water system in the Carriage Oaks Estates subdivision. On June 8, 2018, the Commission issued an order directing notice of the application and setting a deadline of June 29, 2018, for persons requesting to intervene in this matter.

Derald Morgan, Rick and Cindy Graver, William and Gloria Phipps, and David Lott jointly filed a timely application to intervene. Ten days have elapsed, and no party has objected to the application to intervene.¹ The application satisfies all requirements of Commission Rule 4 CSR 240-2.075 and intervention will be granted.

THE COMMISSION ORDERS THAT:

1. The application to intervene filed by Derald Morgan, Rick and Cindy Graver, William and Gloria Phipps, and David Lott is granted.

¹ Commission rule 4 CSR 240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission.
